RE: Revised Rates for Solid Waste and Recycling Services

RECOMMENDATION

It is recommended that the Village Council approve the attached Resolution which provides for an annual fee in the amount of \$525.00 per household for collection of solid waste and recycling services to residential customers in single family and duplex dwellings within the Village.

BACKGROUND

The annual fees for the provision of solid waste collection and recycling services was last established in 2010 in the amount of \$475.00. The rate set forth in the attached Resolution has been established at a level which is sufficient to cover the Village's costs pursuant to the newly awarded service contract to Southern Waste Services on June 23, 2015. In order to off-set the contract increase and continue maintaining a positive carry forward fund balance, the annual solid waste fee will need to be increased to \$525.00.

The revised annual fee of \$525.00 per household for residential customers will become effective October 1, 2015 along with the collection of solid waste and recycling services by the newly contracted company, Southern Waste Services.

RESOLUTION NO. 2015-

A RESOLUTION OF THE VILLAGE COUNCIL OF THE VILLAGE OF KEY BISCAYNE, FLORIDA, REVISING SERVICE FEES FOR THE COLLECTION OF SOLID WASTE AND RECYCLING SERVICES; AMENDING FEES AS PROVIDED BY RESOLUTION NO. 2010-11; REPEALING RESOLUTION NO. 2010-11; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR EFFECTIVE DATE.

WHEREAS, the Village provides for solid waste collection and recycling services to be provided to residential customers within the Village; and

WHEREAS, pursuant to Section 2-61 of the Village Code, the Village Council is authorized to impose fees for the collection of solid waste and recycling services (the "Fees"); and

WHEREAS, in 2010 the Village Council adopted Resolution No. 2010-11 establishing the applicable annual Fee; and

WHEREAS, the Village Council desires to revise the Fees as provided herein; and

WHEREAS, a duly noticed public hearing was held prior to the setting of the revised Fees.

NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF THE VILLAGE OF KEY BISCAYNE, FLORIDA, AS FOLLOWS:

Section 1. **Recitals Adopted.** That each of the above stated recitals are hereby adopted and confirmed.

Section 2. **Revised Service Fee.** That an annual Fee in the amount of \$525.00 per household is hereby set as the regular service charge for the collection of solid waste and for recycling services to residential customers within the Village for the time period beginning October 1, 2015.

Section 3. Repeal. That Resolution 2010-11, which established the prior Fee schedule, is hereby repealed, except that the Fees provided by Resolution 2009-5 shall continue to apply to all unpaid Fees for services which were provided pursuant to Resolution 2009-5.

Section 4. Implementation. That the Village Manager is hereby authorized to take any action which is necessary to implement and enforce this Resolution.

Section 5. Effective Date. That this Resolution shall be effective immediately upon adoption and shall be applied as provided herein.
