Re: Tennis Services at Calusa Mangrove Trail

Dear Todd:

On November 27, 2006, the Miami-Dade Parks Department Director and I met with the Village Manager and yourself to discuss several issues of mutual concern. During the discussion it was mentioned that the Village had authorized an agreement with an individual to provide professional services at the Calusa Mangrove Trail tennis courts.

Because the Crandon Park Tennis Center already offers professional tennis services, the Department feels that it is counter productive to duplicate similar services within another area of Crandon Park. Also, providing such a service at Calusa Mangrove Trail presents a potential conflict with the master plan provision that the courts be available for multi-purpose uses. The Village Manager agreed that the Calusa Mangrove Trail tennis courts should operate without professional tennis services and indicated that existing agreements would be immediately terminated. You also noted that an RFP for tennis services was being contemplated. Given the circumstances our assumption is that this option will not be pursued further.

The Department looks forward to working with the Village on a programming partnership that will provide the framework for both a viable and compatible recreation use of the Calusa Mangrove Trail facilities within the context of the Crandon Park Master Plan.

As always thank you for your cooperation and understanding.
