SPECIAL COUNCIL MEETING

1. **CALL TO ORDER/ROLL CALL OF MEMBERS:** The meeting was called to order by the Mayor at 6:00 p.m. Present were Councilmembers Michael W. Davey, Enrique Garcia, Mayra P. Lindsay, James S. Taintor, Vice Mayor Michael E. Kelly and Mayor Franklin H. Caplan. Councilmember Robert Gusman was absent. Also present were Village Manager John C. Gilbert and Village Attorney Stephen J. Helfman.
2. **PLEDGE OF ALLEGIANCE:** Mayor Caplan led the Pledge of Allegiance.
3. **REPORTS AND RECOMMENDATIONS:** The following item was discussed:

Village Manager. The Manager addressed the Council regarding the Employee Health Insurance. The Manager reported that the Village's Insurance Broker, National Marketing Group Services, Inc., contacted seven (7) insurance companies to bid on the Village's employee health insurance policy.

Mr. Roger Gonzalez, President of National Marketing Group Services, Inc., Insurance Broker of Record for the Village of Key Biscayne and Michelle Febre, addressed the Council reporting that the group census, rates, benefits and utilization went to bid with every Health Insurance Carrier available.

There was extensive discussion from Council on this issue.

Councilmember Garcia made a motion to approve the resolution. The motion was seconded by Councilmember Davey and approved by a 5-1 roll call vote. The vote was as follows: Councilmembers Davey, Garcia, Lindsay, Vice Mayor Kelly and Mayor Caplan voting Yes. Councilmember Taintor voting No.
