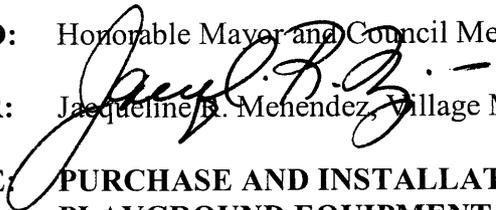

RE: PURCHASE AND INSTALLATION OF
PLAYGROUND EQUIPMENT

RECOMMENDATION

It is recommended that the Village Council approve the contract with GameTime for the purchase and installation of playground equipment for the Village Green.

BACKGROUND

The GameTime equipment on the Village Green was originally purchased on January 6, 1995. Resolution 94-39 authorized a \$128,212.00 contract between the Village of Key Biscayne and GameTime for to purchase and installation of the original playground equipment.

The Parks and Recreation Department has been pleased with the performance of the original equipment. The GameTime equipment has served the Village well for over ten years and withstood a tremendous amount of use.

The current installation and maintenance agreement with GameTime equipment has met the Departments expectations. Fitzgerald Inc. was contracted by GameTime Inc. to perform the installation and maintenance on all of the equipment until 2003. Fitzgerald Inc. was replaced by a local firm. It was determined by departmental staff that the service being provided by this firm did not me the Village's expectations. GameTime Inc. has terminated its contract with the local firm and contracted again with Fitzgerald Inc. who has a history of providing excellent service.

On December 13, 2005 the Village Council placed \$150,000 for playground equipment replacement in the Capitol Projects Fund.

RESOLUTION NO. 2006-

A CAPITAL PROJECT AUTHORIZING RESOLUTION OF THE VILLAGE COUNCIL OF THE VILLAGE OF KEY BISCAYNE, FLORIDA, CONCERNING THE ACQUISITION OF PLAYGROUND EQUIPMENT FOR THE VILLAGE GREEN PARK; AUTHORIZING AND PROVIDING FOR THE VILLAGE TO PURCHASE THE EQUIPMENT; AUTHORIZING EXPENDITURE OF FUNDS; AUTHORIZING AND APPROVING TRANSACTION; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Village Council, upon the recommendation of the Village Manager, desires to obtain certain playground equipment (the "Equipment") for the Village Green Park as described in the attached Quotation from GameTime ("Contractor"); and

WHEREAS, the Equipment is necessary for the enhancement of the Village Green Park; and

WHEREAS, the Village Council finds the purchase of the Equipment to be exempt from competitive bidding pursuant to Village Code Section 2-86 as being derived from another government entity's bid process, as this purchase is based on Florida State Contract No. 650-001-04-01; and

WHEREAS, the Village Council hereby finds and determines that the purchase of the Equipment is in the best interests of the Village.

NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE VILLAGE COUNCIL OF THE VILLAGE OF KEY BISCAYNE, FLORIDA, AS FOLLOWS:

Section 1. Recitals Adopted. That each of the recitals stated above is hereby adopted and confirmed.

Section 2. Capital Project Authorizing Resolution. That pursuant to Village Charter Section 3.07(b), this Resolution shall constitute a Capital Project Authorizing Resolution. The

Capital Project is the purchase of playground equipment for the Village Green Park, at a cost of Forty Two Thousand Two Hundred Sixty Three and 58/100 (\$42,263.58) Dollars.

Section 3. Equipment Purchase Authorized.

A. That the purchase of the Equipment is hereby authorized. The Equipment is further described in the Quotation, a copy of which is set forth in Exhibit "A," attached hereto and incorporated herein.

B. That the Village Council hereby authorizes the Village Manager to complete the purchase transaction for the acquisition of the Equipment for a cost which is consistent with this Resolution.

C. That the Village Manager is authorized to expend Village funds for the purchase of the Equipment in accordance with Village budget appropriations.

Section 4. Effective Date. That this Resolution shall be effective immediately upon adoption hereof.

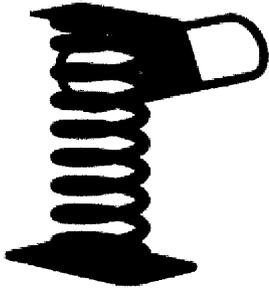

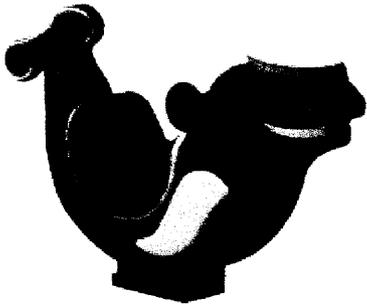
