RE: Revising Service Fees for the Collection of Solid Waste and Recycling Services

RECOMMENDATION

At the conclusion of the public hearing on this item, it is recommended that the Council adopt the accompanying resolution which provides for an annual fee in the amount of \$ 475.00 per household for collection of solid waste and recycling services

BACKGROUND

The Solid Waste Fee ("fee") is a service fee for the collection of solid waste and recycling for the single family and duplex customers. The current contract for solid waste services is expiring at the end of this month and we issued a Request for Proposal for a new contractor. The recommended contractor's rate to the Village is lower than the current agreement. This recommendation will lower the annual household rate from \$ 495.00 to \$ 475.00. The improved collection rate will assist in diminishing or eliminating any operating deficit in this fund while still maintaining our current positive carry forward fund balance.

RESOLUTION NO. 2010-11

A RESOLUTION OF THE VILLAGE COUNCIL OF THE VILLAGE OF KEY BISCAYNE, FLORIDA, REVISING SERVICE FEES FOR THE COLLECTION OF SOLID WASTE AND THE PROVIDING OF RECYCLING SERVICES; AMENDING FEES AS PROVIDED BY RESOLUTION NO. 2009-5; REPEALING RESOLUTION NO. 2009-5; AND PROVIDING FOR EFFECTIVE DATE.

WHEREAS, the Village provides for solid waste collection and recycling services to be provided to residential customers within the Village; and

WHEREAS, pursuant to Village Code Section 2-61, the Village Council is authorized to impose fees for the collection of solid waste and for the providing of recycling services (the "Fees"); and

WHEREAS, pursuant to Resolution No. 2009-5, as adopted by the Village Council on March 24, 2009, the Village Council established the applicable annual Fee ; and

WHEREAS, the Village Council desires to revise the Fees as provided herein; and

WHEREAS, a public hearing was held on March 16, 2010 prior to the setting of the revised Fees.

NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF THE VILLAGE OF KEY BISCAYNE, FLORIDA, AS FOLLOWS:

Section 1. Recitals Adopted. That each of the above stated recitals is hereby adopted and confirmed.

Section 2. Revised Service Fee. An annual Fee in the amount of \$ 475.00 per household is hereby set as the regular service charge for the collection of solid waste and for the providing of recycling services to residential customers within the Village for the time period beginning October 1, 2009.

Section 3. Repeal. That Resolution 2009-5, which established the prior Fee schedule, is hereby repealed, except that the Fees provided by Resolution 2009-5 shall continue to apply to all unpaid Fees for services which were provided pursuant to Resolution 2009-5.

Section 4. Implementation. That the Village Manager is hereby authorized to take any action which is necessary to implement and enforce this Resolution.

Section 5. Effective Date. That this resolution shall be effective immediately upon adoption and shall be applied as provided herein.
