

The following Capital Initiatives and Improvement Priorities were identified by the Council and the public: Burying of power lines, land acquisition, Presbyterian Church project partnership, Dog Park completion, 530 Crandon Boulevard, Beach Renourishment, Transportation issues, Library, Police Parking Lot, K-8 School overcrowding, Beach Club Property, parking, extending the green paint for the bike lanes, sea level rise mitigation plan and implementation, addressing external threats like the Boat Show, Community Drug Abuse Education, MAST Academy Auditorium upgrade, gymnasium at MAST Academy, action on traffic light situation, continued emphasis on public safety, courtesy and civility program.

7. ADJOURNMENT: The meeting was adjourned at 7:05 p.m.


