



VILLAGE OF KEY BISCAYNE VIRTUAL PUBLIC MEETING NOTICE

Elected officials and Village staff will participate through video conference.

Members of the public may watch, listen, or call in to the virtual public meeting by following these instructions.

TO WATCH OR LISTEN TO THE VIRTUAL PUBLIC MEETING

- **Watch the meeting on Comcast/Xfinity:** Channel 77
- **Watch the meeting on ATT UVerse:** Select 99 (Government Channel) on the menu. Select “Village of Key Biscayne” on the list of municipal channels in the submenu.
- **Watch the meeting on your computer/mobile device:**

- **Listen to the meeting from your telephone:** Dial 305-365-7569, then input the Meeting ID: 231 627 8415, followed by #. There is no participant ID. Press # again. You will automatically be muted and will hear a recorded message advising how many participants are in the meeting and that if you wish to speak, you should press *9 and the host will be alerted. See the instructions below for additional information.

TO SPEAK AND PROVIDE PUBLIC COMMENTS AT THE VIRTUAL PUBLIC MEETING

Dial 305-365-7569 then input the Meeting ID: 231 627 8415, followed by #.

There is no participant ID. Press # again.

You will automatically be muted and will hear a recorded message advising how many participants are in the meeting and that if you wish to speak, you should press *9 and the host will be alerted. Pressing *9 is known as “raising your hand.” Once you press *9, you will be placed in a queue to speak and will be called upon by the last three digits of your telephone number. Please wait to be called upon.

When the Mayor or Chair of the meeting recognizes you by the last three digits of your telephone number, the host will “unmute” you and you will hear a message advising you to press *6 to unmute yourself. Press *6 and you will be unmuted and may proceed to deliver your comments.

Before delivering your comments, please provide: Your Name, Address, if you are a hired Consultant or Village Employee, and/or if you are engaged in Lobbying Activities and/or representing an organization.

Please be sure to be in a quiet area to avoid unnecessary noise.

A time limit may be imposed for each speaker during public comment.

Your cooperation is appreciated in observing the time limit.

TO EMAIL YOUR PUBLIC COMMENTS PRIOR TO THE VIRTUAL PUBLIC MEETING

Members of the public may email their public comments to the Village Clerk in advance of the meeting. Please email the Village at publiccomments@keybiscayne.fl.gov by 12:00 p.m. on the day of the meeting with the subject line “PUBLIC COMMENT” and the following information in the body of the email: Your Name, Address, if you are a hired Consultant or Village Employee, and/or if you are engaged in Lobbying Activities and/or representing an organization. Please limit your comments to no more than 350 words. Public comments received via email may be read into the record during the public comment portion of the agenda, if any.

Any person requiring special accommodations to access this proceeding is asked to advise the Village at least 2 days before the proceeding by contacting the Village Clerk at jkoch@keybiscayne.fl.gov.

PUBLIC RECORDS

The meeting will be recorded for later viewing and is a public record. The virtual chat, if any, will be saved and is a public record. Minutes of the meeting will be taken and will be made available.

NOTICE PURSUANT TO §286.0105, FLORIDA STATUTES

IF A PERSON DECIDES TO APPEAL ANY DECISION MADE BY THE BOARD, AGENCY, OR COMMISSION WITH RESPECT TO ANY MATTER CONSIDERED AT THIS MEETING OR HEARING, HE OR SHE WILL NEED A RECORD OF THE PROCEEDINGS, AND FOR SUCH PURPOSE, HE OR SHE MAY NEED TO ENSURE THAT A VERBATIM RECORD OF THE PROCEEDINGS IS MADE, WHICH RECORD INCLUDES THE TESTIMONY AND EVIDENCE UPON WHICH THE APPEAL IS TO BE BASED.

AMERICANS WITH DISABILITIES ACT
