RE: **Request for Approval of Resolution Authorizing the Mayor to Apply to Miami-Dade County for Funds in the Appropriate Amount of \$3,759.00 through the Dade County Drug Control and System Improvement Program FY2007.**

RECOMMENDATION:

I respectfully request the approval of a resolution authorizing the Mayor to apply to Miami-Dade County for funds in the appropriate amount of \$3,759.00 through the Dade County Drug Control and System Improvement Program FY2007. The award of these funds will enable the Village Police Department to purchase four (4) laptop computers that will assist the officers to work more efficiently from their patrol cars and establish wireless access to various databases.

BACKGROUND:

The Village Police Department has been utilizing new technology in order to improve the quality of services it provides to its residents. In doing so, the Village Police Department has utilized laptop computers in the patrol cars that enable rapid access to crime and safety information. However some of these laptops computers have begun to show signs of wear and are costly to repair.

NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF THE VILLAGE OF KEY BISCAYNE, FLORIDA, that this Council authorizes the Village Mayor to apply to Miami-Dade County for funds in the approximate amount \$ 3,759.00; authorizes the Village Mayor to execute such contracts and agreements as are required by this governmental body following their approval by the Village Attorney's Office; to execute such other contracts as will serve further the purpose described in the funding request, following their approval by the Village Attorney's Office; to expend any and all monies received for the purpose described in the funding request; to receive and expend any additional funds that might become available during the term of the grant; to file and execute necessary amendments to the application for and on behalf of the Village of Key Biscayne, Miami-Dade County, Florida; and to exercise amendment, modification, renewal, cancellation and termination clauses of any contracts and agreements on behalf of the Village of Key Biscayne.

Section 4. Effective Date. This resolution shall take effect immediately upon adoption.
