RE: Naming the Park Located at 401 Hampton Lane

RECOMMENDATION

Formally name the park located at 401 Hampton Lane.

BACKGROUND

The Village acquired the property located at 401 Hampton Park for purposes of a public park, in part, using grant funds from the Florida Communities Trust. The park was developed in collaboration with Village residents dedicating countless volunteer hours.

The grant requires signage be installed at the park acknowledging the grantor. The official name of the park should be included in the signage but is not required. An attempt to name the park via a community naming contest failed. Council's desire to name the park remained. The attached resolution provides the opportunity for the Council to name the park.

We recognize that there is additional value added to the community by naming the park. The Village is currently working on an infographic promotional communication campaign that will provide residents with details regarding all the parks within the Village of Key Biscayne. The initiative would showcase the parks, tangible assets acquired and maintained using tax payer dollars and tireless volunteerism. It would be beneficial to include the formal name of this park in the promotional campaign material.
