A RESOLUTION OF THE VILLAGE COUNCIL OF THE VILLAGE OF KEY BISCAYNE, FLORIDA, AMENDING RESOLUTION NO. 2019-66 ESTABLISHING THE VILLAGE'S 2020 LEGISLATIVE APPROPRIATION PRIORITIES; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Village of Key Biscayne (the "Village") Council adopted Resolution No. 2019-66 on October 29, 2019 to establish certain appropriations as the Village's 2020 legislative appropriation priorities; and

WHEREAS, the Village Council wishes to amend Resolution No. 2019-66 to establish the appropriations set forth in Exhibit "A" attached hereto as the Village's 2020 legislative appropriation priorities.

2020 LEGISLATIVE APPROPRIATION PRIORITIES

The following are established as the Village of Key Biscayne s 2020 Legislative Appropriation Priorities

APPROPRIATIONS

- 1 The Village supports grant and legislative line item funding that enhances local financial capacity to address water resources, drainage flood mitigation, sea level rise and water supply development Specifically the Village requests \$750 000 for stormwater utility improvements, toward which the Village is prepared to invest \$18,000,000
- 2 The Village supports grant and legislative line item funding that supports the acquisition of land for public parks and green spaces The Village is particularly interested in securing Florida Communities Trust support for the acquisition of 571 and 599 Harbor Drive properties in the amount of \$1,640,000
- 3 The Village supports grant and legislative line item funding that enhances water quality _
