
The Mayor addressed the Council welcoming the public to the Workshop on Park Uses for 530 Crandon Boulevard.

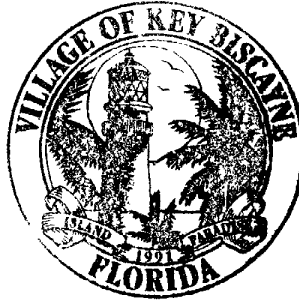


