**AN ORDINANCE OF THE VILLAGE COUNCIL OF THE VILLAGE OF KEY BISCAYNE, FLORIDA (“VILLAGE”), AMENDING THE VILLAGE CODE BY AMENDING CHAPTER 23 “RETIREMENT,” SECTION 23 35 “CONTRIBUTIONS,” TO PROVIDE THAT THE PLAN WILL CONTINUE TO MEET STATUTORY MINIMUM BENEFITS AND STANDARDS, PROVIDING FOR SEVERABILITY, PROVIDING FOR CONFLICTS, PROVIDING FOR INCLUSION IN THE CODE, AND PROVIDING FOR AN EFFECTIVE DATE**

Mayor Lindsay made a motion to adopt the ordinance on first reading The motion was seconded by Vice Mayor Caplan

The Mayor opened the public hearing There were no speakers present The Mayor closed the public hearing

The Clerk read the following ordinance on second reading by title

**AN ORDINANCE OF THE VILLAGE OF KEY BISCAYNE, FLORIDA, AMENDING CHAPTER 7, "BUSINESS REGULATIONS" OF THE VILLAGE CODE OF ORDINANCES TO INCLUDE SECTION 7 4, "PROHIBITION ON DISTRIBUTION, SALE, OR USE OF PLASTIC STRAWS", PROVIDING FOR SEVERABILITY, PROVIDING FOR INCLUSION IN THE CODE, PROVIDING FOR CONFLICTS, AND PROVIDING FOR AN EFFECTIVE DATE**

Councilmember Moss made a motion to adopt the ordinance on second reading The motion was seconded by Mayor Lindsay

The Mayor opened the public hearing There were no speakers present The Mayor closed the public hearing

Councilmember Moss made a motion to amend the ordinance by replacing businesses with commercial establishments remove the words used or be used and lastly replace individuals to violators The motion was seconded by Vice Mayor Caplan and approved by a 7 0 voice vote The vote was as follows Councilmembers de la Cruz Gross McCormick Moss Petros Vice Mayor Caplan and Mayor Lindsay voting Yes

**AN ORDINANCE OF THE VILLAGE OF KEY BISCAYNE, FLORIDA, AMENDING CHAPTER 2, ARTICLE XV "YOUTH ATHLETICS ADVISORY BOARD," TO REDEFINE THE JURISDICTION OF THE ADVISORY BOARD, PROVIDING FOR SEVERABILITY, PROVIDING FOR CODIFICATION, PROVIDING FOR CONFLICTS, AND PROVIDING FOR AN EFFECTIVE DATE**
