REGULAR COUNCIL MEETING
KEY BISCAZYNE, FLORIDA

TUESDAY, NOVEMBER 19, 2019

COUNCIL CHAMBER
560 CRANDON BOULEVARD

1. **CALL TO ORDER/ROLL CALL OF MEMBERS:** The meeting was called to order by the Mayor at 6:00 p.m. Present were Councilmembers Luis Lauredo, Edward London, Brett G. Moss, Kathleen Petros (arrived at 6:04 p.m.), Ignacio Seguro, Vice Mayor Allison McCormick and Mayor Michael W. Davey. Also present were Village Manager Andrea Agha, Village Clerk Jennifer Medina and Village Attorney Chad Friedman.
2. **PLEDGE OF ALLEGIANCE:** The Mayor led the Pledge of Allegiance.
3. **BRIEF COMMENTS BY COUNCIL:** The Mayor acknowledged Key Biscayne residents Nicolas Diaz and Luca Civetta for being selected to play on the Junior Men's U-16 National Team and also, acknowledged the Piano Concert participants and contributors that took place on November 15th, 2019. Councilmember Moss addressed the public and the Council regarding identity theft scam. The Mayor also, wished Councilmember Moss a Happy Birthday.
4. **AGENDA:** Vice Mayor McCormick requested the addition of a discussion regarding seaweed management as Item 10A8. Councilmember Petros requested the addition of a discussion regarding an update on the beach feasibility study as Item 10A9. Councilmember Moss requested to hear Item 10A7 together with Item 6A. The Manager requested to pull Item 7D from consent agenda. There were no objections by Council to the agenda changes.
5. **PUBLIC COMMENTS:** The following residents addressed the Council: Antonio Camejo, 151 Crandon Boulevard, commented on the Library; and Ann Taintor, 170 Ocean Lane Drive, commented on grants and funding.

At this time, the Manager addressed the Council regarding this resolution.

Councilmember London addressed the Council regarding routinely bidding all Village services.

There was extensive discussion by Council regarding competitively bidding all Village services.

The resolution was approved by a 7-0 voice vote. The vote was as follows: Councilmembers Luis Lauredo, Edward London, Brett G. Moss, Kathleen Petros, Ignacio Segurola, Vice Mayor Allison McCormick and Mayor Michael W. Davey voting Yes.

8. **ORDINANCES:** The Clerk read the following ordinance on first reading, by title:

AN ORDINANCE OF THE VILLAGE OF KEY BISCAYNE, FLORIDA, AMENDING CHAPTER 8, "ENVIRONMENT" OF THE VILLAGE CODE OF ORDINANCES BY CREATING ARTICLE IX, "FERTILIZER USE" RELATING TO THE USE OF FERTILIZERS WITHIN THE VILLAGE; PROVIDING FOR SEVERABILITY; PROVIDING FOR CODIFICATION; PROVIDING FOR CONFLICTS; AND PROVIDING FOR AN EFFECTIVE DATE.

Councilmember Lauredo made a motion to adopt the ordinance on first reading. The motion was seconded by Mayor Davey.

There was extensive discussion by Council regarding this ordinance.

Councilmember Petros addressed the Council regarding challenges with enforcement, best practices and a public outreach program.

At this time, the Mayor addressed the Council regarding requiring all commercial and institutional applicators to complete a six-hour training program.

Councilmember Segurola addressed the Council regarding Village operational changes, if any and also the implementation of a robust public outreach program.

It was the consensus of Council to direct the Manager to bring back solutions to overcome enforcement challenges and best practices from surrounding municipalities at the regularly scheduled January Council meeting.

Councilmember London addressed the Council regarding removing the requirement for all commercial and institutional applicators to complete a six-hour training program.

The Manager addressed the Council regarding returning to Council with best practices from surrounding municipalities and enforcement solutions.

The ordinance was adopted on first reading and approved by 6-1 roll call vote. The vote was as follows: Councilmembers Luis Lauredo, Edward London, Brett G. Moss, Kathleen Petros, Ignacio Segurola, Vice Mayor Allison McCormick and Mayor Michael W. Davey voting Yes. Councilmember Edward London voting No.

9. **RESOLUTIONS:** The Clerk announced the public hearing for the following resolution and read the resolution, by title:

The Mayor made a motion to approve the resolution. The motion was seconded by Councilmember Moss.

At this time, the Mayor addressed the Council regarding necessary directional signage on the intersection of Crandon Boulevard and Galen Drive.

There was extensive discussion by Council regarding this resolution.

Vice Mayor McCormick addressed the Council regarding allowing Mr. Joseph M. Corradino from The Corradino Group to present at the next regularly scheduled Council meeting regarding signage on Crandon Boulevard.

The resolution was approved by a 7-0 voice vote. The vote was as follows: Councilmembers Luis Lauredo, Edward London, Brett G. Moss, Kathleen Petros, Ignacio Seguro, Vice Mayor Allison McCormick and Mayor Michael W. Davey voting Yes.

Moss, Kathleen Petros, Ignacio Segurola, Vice Mayor Allison McCormick and Mayor Michael W. Davey voting Yes.

Village Manager. The Manager's report was heard earlier in the meeting.


11. **OTHER BUSINESS/GENERAL DISCUSSION:** There was no further business discussed.
