

ORDINANCE NO. 2016-9

AN ORDINANCE OF THE VILLAGE OF KEY BISCAYNE, FLORIDA; ADOPTING THE BUDGETS FOR THE FISCAL YEAR COMMENCING OCTOBER 1, 2016 THROUGH SEPTEMBER 30, 2017 PURSUANT TO FLORIDA STATUTE 200.065 (TRIM BILL); PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Village Manager presented to the Village Council a "Tentative General Fund Operating Budget" for the fiscal year commencing October 1, 2016 and the Village Council scheduled the public hearing required by Section 200.065(2)(c) of the Florida Statutes to be held on September 13, 2016 at 7:00 p.m.; and

WHEREAS, the Property Appraiser has properly noticed the public hearing scheduled for September 13, 2016, at 7:00 p.m., in the Council Chamber, located at 560 Crandon Boulevard, Key Biscayne, Florida, as required by Chapter 200 of the Florida Statutes; and

WHEREAS, said public hearing, as required by Section 200.065 (2)(c), was held by the Village Council on September 13, 2016, commencing at 7:00 p.m. as previously noticed and the public and all interested parties having had an opportunity to address their comments to the Village Council, and the Village Council having had an opportunity to amend the tentative budget as it deemed appropriate and having considered the comments of the public regarding the tentative budget and having complied with the "TRIM" requirements of the Florida Statutes; and

WHEREAS, pursuant to Section 200.065(2)(d) of the Florida Statutes, a final public hearing to adopt the budgets for the fiscal year commencing on October 1, 2016, through September 30, 2017, was held, as advertised, on Tuesday, September 27, 2016, at 7:00 p.m., in the Council Chamber, located at 560 Crandon Boulevard, Key Biscayne, Florida and the Council considered comments from the public.

NOW, THEREFORE, BE IT ORDAINED BY THE VILLAGE COUNCIL OF KEY BISCAYNE, FLORIDA:

Section 1. Upon prior adoption of the final millage rate, which is hereby ratified, the attached budgets of the Village of Key Biscayne for the fiscal year commencing October 1, 2016, are hereby approved and adopted.

Section 2. This Ordinance shall be effective upon adoption on second reading, and shall be applicable from and after October 1, 2016.

After 40 years in state government, Liz Dudek's retiring as head of AHCA

LIZ DUDEK, secretary of the Agency for Health Care Administration, will retire Oct. 3 after more than 40 years in state government. Sam Verghese, head of the

Department of Elder Affairs since 2014, is stepping down to be replaced by Scott's top pick for insurance commissioner, who was rejected for that job by the Cabinet this spring. Dudek and Verghese earned \$141,000 a year.

Dudek, 65, was one of the last remaining agency heads appointed in the early months of Scott's administration and oversaw a complete reform of Medicaid. "Under her leadership, we have worked to make hospitals more transparent and accomplished historic Medicaid reform," Scott said. "She has done an outstanding job making sure all Floridians have the opportunity to lead a healthy and safe life."

Deputy Secretary Justin Senior, who oversees the state Medicaid program, will succeed Dudek as interim AHCA secretary. A lawyer by training, Senior, 45, played a key role in shifting the state Medicaid program to managed care. He negotiated with the federal government during a 2015 dispute over Medicaid expansion and cuts in funding to a program that covered hospital costs for the uninsured.

Twice, Scott and Florida's Chief Financial Officer Jeff Atwater deadlocked over whom to pick. Atwater refused to accept Bragg, while Scott refused to go with Atwater's choice of Rep. Bill Hager.

This isn't the first time Scott has tried to get Bragg, 67, a job running a state agency. Scott tried to appoint him insurance commissioner in the spring.

Deputy, suspect injured after chase leads to crash

A Broward Sheriff's Office deputy and a suspect were both hospitalized Wednesday afternoon with non-life-threatening injuries after a chain of events that included a shooting, chase and crash.

It all started at about 2 p.m. in the parking lot of the Dolphin Harbor Inn at 4245 N. Ocean Dr. in Lauderdale-by-the-Sea, BSO said. Bro-

ward Sheriff Scott Israel said the deputy, spotted a suspect wanted for aggravated fleeing and petty theft.

The deputy tried to stop the suspect in the hotel parking lot, Israel said. "Deputies set up in a nearby hotel and they watched the subject inside his vehicle," he said. "They approached the subject. They gave him clear and concise orders to exit his vehicle." That's when Israel said

the suspect backed his Ford Focus into the deputy's car and the deputy, who was standing near the Focus. "The deputy, who has not been identified, opened fire. The deputy was taken to Imperial Point Hospital and treated for "assorted injuries." The suspect took off and other BSO units went after him, Israel said. The suspect crashed his car into two parked cars in front of Holy Cross Hospital, 1900 E. Commercial Blvd. That's when deputies realized the suspect had a bullet wound in his upper arm. He was taken into custody and brought to Broward General Medical Center for treatment, Israel said.

Alt-right activist Milo says he was rejected from UM appearance

Conservative firebrand Milo Yiannopoulos is no longer officially speaking at the University of Miami.

Yiannopoulos was invited to speak Oct. 3 by the UM College Republicans, according to a piece on Breitbart, an all-right site he edits and writes for. The event (or its cancellation) is mentioned nowhere in recent social-media posts by the group, which did not respond to multiple requests for comments. It was canceled, he said, due to unspecified "security concerns."

Peter Howard, a UM spokesman, said Yiannopoulos approached the club first. "The College Republicans met with University of Miami staff to review operations and logistics needed to host the speaker. The College Republicans decided not to pursue the event," he wrote in a statement.

Yiannopoulos, a self-proclaimed troll, is beloved by the alt-right, anti-feminists and Donald Trump supporters. He frequently talks about the importance of free speech and exposing college students to differing ideas. Yiannopoulos is gay, and is a nod to his habit of not being "politically correct" he named his tour after a gay slur. The "Dangerous

F---" tour includes stops at Florida State University, the University of South Florida, the University of Central Florida and Florida Atlantic University. A University of Florida conservative club

invited him to speak at the school, as well, but it's not on his official calendar. UM revoked Yiannopoulos' speaking invitation over concerns that the school couldn't provide adequate security, he said. His events are commonly met with protests and, at times, violence.
